NOTIFICATION

No. 5/8/2008-Leather- The Central Government has approved a sub-scheme, "Mission Mode", under the Indian Leather Development Programme (ILDPP) for implementation during the 11th Five Year Plan period.

2. The aims of the Mission Mode sub-scheme are as under:-

- To create awareness in the International Markets about India's manufacturing capabilities, economic growth and opportunity potential of the Indian Leather Industry for attracting Foreign Direct Investment / Joint Venture / presenting India as an investment destination in the foreign markets.
- Analysis of existing problems in implementation, development and formulation of projects/schemes for the future by way of research and study of the leather sector.
- Appointment of Consultants for evaluation of the various sub-scheme under ILDP.
- Holding international conferences, fairs (both domestic and international) and seminars in India on topics and themes of interest to the leather industry.
